Approval of Minutes: Approval of the minutes of the 8 January 2025 meeting.

<u>Treasurer's Report:</u> Paul LaBrie stated that the balance in our bank account continues to decrease and that he will monitor it closely.

**CVC/VCOC:** Ruth McWilliams stated that the quarterly meeting of the VCOC was postponed.

<u>Programs:</u> Tad provided information to the board about our speaker for February. Although he is no longer a BOD member, he will continue to be involved in identifying speakers for our meetings. He believes that it may be helpful for the invitations to come from him since he is a Lieutenant General. BOD members also need to contribute to identifying speakers. Ruth McWilliams proposed a speaker and will ask this individual about his availability. (The topic might be "Jefferson and the Barbary Pirates". She also stated that the person who chooses the speaker could also take care of coordinating the arrangements. Tad will think about a speaker for the October meeting.

<u>Legislative:</u> Dan Moy was absent but sent an email stating that some of the MOAA initiatives for 2025 may be approved by the state legislature.

<u>Membership:</u> Carolyn reported that the membership numbers are not accurate in the database online since it is the beginning of a new membership year, and many people have not yet paid their dues.

Steve stated that he had already spoken with Bill Tunner about the responsibilities of his position. Steve further stated that he would attend the JROTC award ceremony at Orange County High School, which will be held on March 1, 2025.
